



### **CODE OF CONDUCT 2024/25**

Any person/s found to be vandalizing the facility used for any event organized by Leicestershire & Rutland ASA will be reported to the organizer and may be requested to leave the location. Likewise if found to be misbehaving, abusing and of bringing our sport into disrepute in the Changing Room area may well be requested to leave the location

Any swimmers in swimsuits observed climbing over any Spectator Poolside Barriers may be requested to leave the location. All swimmers must wear poolside shoes and club outerwear at least when leaving the poolside. Swimmers must change in the wet changing room areas only.

Any person/s found to be verbally or physically aggressive to Staff employed at the facility or any Official or volunteer assisting with the event may well be requested to leave the location and reported to their club

We will expect all attending LASA events to follow the relevant Swim England Code of Conducts

A Leisure Centre Lifeguard will also patrol the Changing Areas during the Galas to ensure swimmers are adhering to the Conduct of Conduct and will report any bad behavior.

The Community pool, where available must only be used for the warm up/cool down swims.

No food or hot drinks are allowed anywhere on the poolside. Unless there is a medical reason, for non adherence, which is to be made known to Leisure Centre and Promoter of event in advance.

Mobile phones and devices are not to be used under any circumstances in a changing room area during a Swim England regulated activity. That applies to Officials, Coaches, Team Managers, Chaperones, Volunteers and Swimmers. Leisure Centre rules will apply with regard to the use of mobile phones and devices away from the poolside and changing rooms.

LASA is permitting photography of presentations only and it is up to the club to remove any person who needs not to be photographed.

NB- All presentations require all swimmers to be dressed, preferably in club kit.

Any person/s or clubs who place images of swimmers on their social media sites are responsible for any resultant complaint/litigation resulting from their action/s. LASA cannot police what Facebook and Twitter and other Social Media sites themselves cannot control.

Safeguarding- Wavepower 2024 v2-LASA is committed to safeguarding all in line with national legislation and relevant guidelines.

LASA will not tolerate abuse of a person due to their race, colour, religion, age or gender identity.
