Minutes of Meeting held on Tuesday 8th July 2025

58/25: Apologies: Paul Sippitt, Sue Wainscot, Stacie Currie, Helen Bickerstaff, Sam Winter, Val Dunton. Zoe Lee, Jenny Beech, Tom Whitmore, Chris Perkins, and Jill Stidever were also absent from the meeting.

59/25: Confirmation of the Minutes of the meeting held on Tuesday 10th June 2025:

It was agreed that the June 2025 minutes which were proposed by Judy Leader and seconded by Geoff Robilliard were a true record. All present in favour.

60/25: Matters Arising from the meeting held on 10th June 2025:

57/25 (b) Confirmed that Geoff had purchased the yellow and black trunking in 1m strips to cover the cables.

63/25 Reports:

a) Treasurer

c) Swimming Report - discussion led by Ursula.

Jenny has been appointed as the Events Manager; initial meeting was held on 7th July. Geoff will support Jenny this year, Age Groups are in a good position.

Medals are in a good position for Age Groups, however there is still a requirement for a Trophy co-ordinator and a Volunteer coordinator. Lee will initially set up the volunteer job roles on Swim Meet which would open up the invitations to all club members and parents.

Interclub invites, there is a requirement to have visibility of when these will be shared.

Post meeting update provided by Sue.

Inter Clubs 6th September:

Information has now been sent to Leicester Sharks and the Conditions of Entry will be circulated to all clubs in the next few days. The decision to permit one team only for 2025 will stand due to H&S issues on poolside if we add any B Teams. Braunstone won the trophies in 2024, and they will be contacted to arrange the return of these; hopefully, they have been engraved by the club.

Inter County Team Championships Sheffield 5th October:

Team selection almost complete; put together in conjunction with COLSC Coaches; just a couple of outstanding queries. Selections based on short course ranking times subject to the maximum permitted team size of 32 swimmers. Harry Pickering and Jamie Black have agreed to Coach the team at the event. Information has yet to be published by Swim England

Swim Clinics:

Dates now set: 27th September; 1st November; 22nd November; 13th December.

First clinic is backstroke, and a communication is due to go out this week to confirm the number of spaces for each club.

The age ranges are 10-13 & 14 & over (as at 31.12.25). The total number of places for each date is 64.

The first camp will start around 12.30pm and the second camp will start around 2pm; each camp running for approximately 3 hours.

He would however meet with those who had signed up in person to discuss the process or refer them to their club coordinator who could lead the initial session, if confident to do so.

He had also made mention of the interpretation /guidance for using/banning mobile phones in changing rooms, but he was aware that Ursula was also looking into this.

1. LASA Treasurer's Report for June 2025

LASA Treasurer's Report for July 2025 Meeting

Main Points

- The financial reports attached cover the period of 1st 30th June 2025.
- Income is attributable to Accreditation Fees and bank interest.
- Expenditure is attributable to the regular outgoings (COL, Workspace, software etc), and the purchase of 10 radios for use at Club Champs and other galas.
- The Financial Review and next year's Budget meeting has been set for Tuesday 12th August 2025. All funding requirements and expenditure needs to be submitted before 31st July so the budget can be prepared and distributed prior to the meeting.

Cash Flow for the Financial Year – showing financial year to date. Profit & Loss for June 2025 –a Deficit is reported as expected at this time in the Financial Year. Balance as at 30th June 2025 – showing overall financial position.

2. Officials Report for July 2025 Meeting

Congratulations to Christine Davies, Gary Patterson and Matthew Streeter who successfully passed their final poolside assessment as starters.

Thanks to Hinckley S.C. for allowing the testing to take place at their open meet at the end of June.

Officials update.

June's qualified and trainee list have been provided by SE and are a very accurate reflection of the officials we have in Leicester currently, with only a few queries related to license information. I have communicated to each club coordinator the officials I have on record for their club for clarification.

Judge 2 workshops. With such few numbers of Judge 2 signups, I haven't looked at organising any initial group workshops which are ideally required before they go poolside in this role. I will make every effort to meet these people in person to discuss the process or refer them to their club coordinator who can also lead this initial session if confident to do so.

LASA Masters

The LASA Masters Open Meet has now gone live on Swim Meet, and we have a steady flow of signups to date, I will continue to request officials throughout the summer. The link to sign up can be found here.

3. LASA PRESIDENTS REPORT - JULY 2025

15 June - Attended City of Leicester Open Meet on the Sunday. Ideally with my presidential hat on but, in the event as an official. Had Sue and I not attended and worked poolside, the stalwart few that were there would have not been sufficient in number to certify the gala as fully staffed. As it was, we were on a precipice of legality in respect of event licencing requirements. We had to repeatedly adjust the available staff to ensure that there was adequate coverage. It was a busy day.

I emphasise here that it is my view that the swimming and the gala was administered in a right and proper manner, with the principle of fairness applied to all. That is undoubted. It is my belief that the spectators and the swimmers enjoyed the event and that the results produced some outstanding efforts – it was a wholly successful meet. City of Leicester are to be congratulated.

I am aware that there has been a great deal of valiant effort put into volunteer recruitment in Leicestershire - but what else can we do? What are we missing? AND I concur that I personally may be part of the problem!

21 June. The LASA Diddy Gala 'A' final at Corby International Pool. Uninvited, I attended as president and took the opportunity to be a spectator – it amused me that this is the first gala since around 1990 that I have been obliged to enter as a paying spectator! Still, it's £1 well invested. Sorry £2 – Sue went too. No regrets.

Teams from Melton Mowbray, Corby, Market Harborough, Coventry, Sharks, Rushden and Nene, Coalville, Loughborough took part and proudly displayed their banners. It was a commendably 'loud' gala.

There was some intense swimming, and places changed frequently as the gala progressed with (provisionally) Corby coming out as overall winners of the League. Happy smiling faces everywhere – Diddy galas are where we see true enthusiasm, delight, and total joy from the participants – before they grow up and the world turns them into teenagers???

It was a pleasure to sit up there in the gods with no administrative responsibility. A first for many years. With the prior approval of the lead referee, the President donned his formal hat and went to each team speaking to the Team Managers to thank them on behalf of LASA for their enthusiasm and support for the next generations.

BUT – and here lies a bit of the anomaly causing my previous comments – I noted that there were FIVE fully qualified and much experienced working referees poolside. There appeared to be NO shortage of additional qualified officials in the role of judges and chief timekeepers, all timekeeper positions were fully staffed and turn judges were of an experienced group. Indeed, there were at least two trainee referees (perhaps now qualified?) helping out with the Corby team acting as Team Managers. Northamptonshire appear to be able to keep officials far beyond just J1 status.

In Leicestershire, can we learn anything from whatever alchemy that exists in Northamptonshire? I live on the county border - and I'll be the first to admit that it baffles me!

A comparison of administration. A bigger paradox.

At Braunstone, the City of Leicester Open Meet, anyone wishing to video or photograph swimmers had been issued with a coloured wristband to denote their registration for that facility. It was announced that cameras should not - in any circumstances be used in the changing rooms. Photographers in the adjacent balcony with a coloured wristband not clearly displayed were challenged by the referee(s) to produce one. At Corby, a similarly Council run facility, there are a number of LARGE (A1?) sized posters on entry to the changing rooms and within in the changing rooms placed there by the Pool Operator, advising that cameras should not be used there. Additionally, Corby Swimming Club had supplemented those with their own A4 posters.

Corby pool has a more 'remote', higher balcony - virtually unviewable from poolside. Some members will know the layout well. Not unlike Coalville and Hinckley - but bigger and higher. Monitoring of photographers from poolside is virtually / practically impossible.

Announcement was made that photographers had no need for registration - but that they should be mindful of taking close up photos of their own swimmers only and seek to exclude other swimmers from the field of view. Frankly, having been sat up on the rear row of that large balcony and looking over the shoulders of spectators to see what they were doing, there is little or no monitoring of their activities. THIS IS NOT A CRITICISM OF CORBY SWIMMING CLUB OR THEIR ADMINISTRATION. They do what they can reasonably. Indeed, spectators are actually encouraged and required to use their devices to access the programme, as paper, printed programmes are not available and are viewable only on the Club website - an innovation saving paper and the planet.

This means that devices are very much in evidence and so used. But without 'photography police' constantly and frequently patrolling at the rear of the balcony and being able to intimately view the screens of many

differing and multiple devices over the shoulders of five rows of almost 200 'banked' spectators, there is little actual feasible control.

So, here's the paradox.

1) Some of the swimmers who were at Braunstone were also at Corby. 2) The events are being run under the same national governing body - Swim England. 3) Both venues / clubs are in East Midland Region 4) LASA was 'locally' involved in both galas.

Now, I'm NOT saying here that either approach at either venue is right or wrong. But the difference is stark. What I am saying is that the <u>inconsistency</u> is wrong. Between these two approaches there has to be a practical and happy medium and, in my view, this 'direction' should be coming from Swim England nationally.

Throw into the equation too, the sometimes LIVE broadcast of events via the internet which is essentially 'open season' for any individual with nefarious inclinations. How can that be 'policed'?

Without <u>any shadow of doubt</u>, 'phones are NOT to be used by anyone, (especially those with Swim England affiliation) within the changing room areas. Sanctions are available. That is clear cut.

But the use of recording devices on the poolside and from the balcony is, at best, "woolly"; at worst BY ITS INCONSISTENCY IN LOCAL INTERPRETATION, "silly"?

The Chair of LASA in her role as Regional Welfare Officer, has said that she will address these two 'extremes' with SE to provide more consistent guidance. Thank you, Ursula.
